Investment Objective

The Boston Trust Midcap Fund seeks long-term capital growth through an actively managed portfolio of stocks of middle capitalization ("midcap") companies.

Investment Strategy

The Fund invests at least 80% of its assets in domestic and foreign equity securities. "Assets" means net assets, plus the amount of borrowing for investment purposes. Shareholders will be given 60 days advance notice of any change to this policy. For these purposes, the Adviser defines midcap companies as those with market capitalizations within the range encompassed by the Russell Midcap® Index at the time of purchase. As of June 30, 2011, the market capitalization range of the Russell Midcap® Index was between \$1.4 billion and \$17.9 billion. The Fund also may invest in foreign securities.

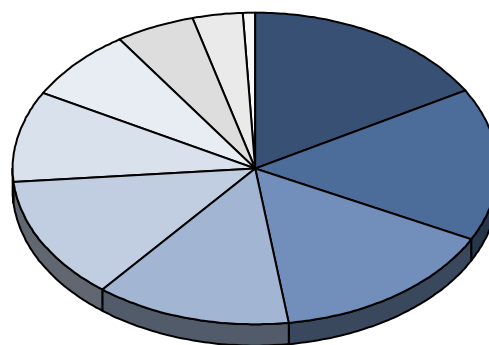

The Russell Midcap® Index represents approximately 27% of the total market capitalization of the Russell 1000 companies.
